

Visa for certain countries

1. Requirements

Passport holders from the countries below are required to submit additional documents to apply for a tourist Visa

The applicants must have a permit of residence in Belgium or in Luxembourg

**** The Embassy cannot take any decision concerning your Visa application. Your documents will be submitted to the Thai Ministry of Foreign Affairs for approval**

*** These countries please DO NOT purchase the flight tickets or accommodation until your Visa is approved**

*** Visa application must be submitted before travel date at least 4 weeks**

2. Documents required

- 1) **A passport or travel document** that is still valid for at least 6 months and contains at least one empty page
- 2) 1 copy of the **passport or travel document** (the first page with your photo)
- 3) 1 original **application form** well filled in and signed by the applicant
- 4) 2 recent **color passport photographs**, 3,5 + 4,5 cm taken within the last 6 months. All the photos must look the same.
- 5) 1 copy of a valid **Belgian or Luxembourgish identity card or permit of residence**. The residence permit must be valid during the period of travelling and returning to Belgium or Luxembourg
- 6) 1 copy of a **reservation/booking airline tickets**, showing the name of the applicant, **arrival and departure dates** for Thailand. Please do not buy the ticket until you have the Visa
- 7) 1 copy of a **hotel/accommodation reservation** in Thailand for the whole period of stay. The name of the applicant, full address and date of arrival and departure must be mentioned on the document

1 copy of a letter or mail from a guarantor in Thailand inviting you to stay in his/her home. The letter must mention the name of the applicant, full address in Thailand and the date of arrival and departure. The guarantor must submit his/her copy of Thai identity card and proof of residence in Thailand (Tabian Baan)

8) 1 copy of the applicant's **employment contract** mentioning the job position, salary and duration of the employment contract

- If the applicant is a student, please include a confirmation letter in English from the school
- In case of unemployed MUST having a sponsor, please bring:
 - 1 copy of his/her identity card
 - 1 copy of his/her 3 last payment slips
 - A formal letter of your sponsors identifying who is he/she? And the relationship you have with this person

9) 1 copy of the applicant's **bank statements of the 3 last months**

10) **Only if you have a travel document**, the applicant must show a proof of their nationality before the refugee status (old identity card, old passport, birth certificate, driving licence,...)

Please note that these **documents** are **COMPULSORY** to apply for the Visa and we will **NOT** take your Visa request into consideration if one or more documents are missing!

THE CONSUL MAY ASK FOR MORE DOCUMENTS IF DEEMED NECESSARY

Visa submission time is from Monday to Friday from **9.30 till 12.00 O'clock ONLY**

Visa pick up time is from Monday to Friday from **14.00 to 15.00 O'clock ONLY**

Note:

- Please submit your application at least 4 weeks before travel date
- Consular officers reserve the right to reject any application without having to provide a reason
- After the Visa application has been accepted, the Embassy may ask for an interview
- The Embassy does not provide copying or printing service. Please always bring your own copies. The Embassy reserves the right to keep all your documents as reference after processing your Visa application

3. Visa fee

30 € to pay cash when submitting the Visa application
